- 01. Application is to be made in the prescribed Application Form (Proforma Annexure-I).
- 02. (a) Processing fees to be paid in cash in Vijaya Bank, OGNBC Branch, OSHB, Head Office, Bhubaneswar / Rourkela Branch Office, Rourkela.
 - (b) Processing fees to be paid in Draft favouring "Odisha Housing Board Fund" payable at Bhubaneswar.
 - (c) The required processing fees for different category are as follows:

The processing fee will be charged @ 5% of the prevailing bench mark value of the land, fixed by Govt. in the scheme area, irrespective of execution of lease deed or not, by the original allottee / Transferor. The above rate shall not be less than the minimum processing fees as under for different categories :
