Sealed quotation/tenders are invited from interested reputed Travel Agencies/ Tour Operators or Private individuals for providing one AC Ciaz /Honda City of ZX CVT/VX CVT (Petrol) model, which shall confirm to terms and conditions annexed as 'Annexure -II' to this notice, for official use of Odisha State Housing Board on monthly rent basis for a period of one year ;

1. The vehicle must be in road worthy condition, shall not be more than 03 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs.5000/- (Rupees Five thousand) only shall be deposited by the intending bidder in shape of Account Payee Bank Draft drawn in favour of 'Orissa Housing Board Fund' payable at Bhubaneswar and submitted along with tender as security deposit. After completion of the tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in general bid information (excluding fuel and lubricants).
6. The vehicle must achieve a minimum fuel efficiency of 12 Kms per litre.
7. The details of the make and year of manufacture of the vehicle, registration No., mileage (Kms covered per litre) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender in the sample format annexed as 'Annexure-III'.
8. The Quotation completed in all respect should reach the undersigned on or before 08.07.2022 by 03.00 pm and shall be opened on the same day at 04.30 pm in presence of the bidders or their authorised representatives.
